BRIEF DESCRIPTION

The MEDSTAT IV project provides expertise and technical support to promote the harmonisation of statistics in line with EU and international standards in six domains: business register and business, trade and balance of payments, energy, labour market, migration and transport). It follows on the previous phase implemented over the period 2010-2013.

COUNTRIES COVERED

Algeria, Egypt, Israel, Jordan, Lebanon, Libya, Morocco, Palestine, Syria and Tunisia (cooperation with Syria is suspended).

OBJECTIVES

The overall objective of the project is to promote evidence-based decision-making and to foster democratic development by improving the availability, visibility and accessibility of robust, reliable and timely statistical data in the ENP-South countries.

ACTIONS IN BRIEF

This will be achieved through four complementary actions:

- Contribution to the production of better quality data in the priority thematic sectors.
- Support to working groups through relevant and timely expertise and activities.
- Harmonisation of statistical data in line with European and international standards.
- Raising awareness on statistics for a number of stakeholders, including a more user-friendly dissemination of statistics.

INTRODUCTION

Statistical Business registers (SBR) are important for the quality and relevance of the outputs of business statistics as they are the main source for drawing representative samples for the design and implementation of business surveys. The challenge for the National Statistical Systems is not only with creating a register but mainly with making sure that it is regularly updated, businesses being transformed, closed and opened every day. A reliable updating process involves all the actors that regularly gather information on businesses, the statistical office but also other economic and social administrations.

At the occasion of the 1st Working group meeting for the sector of Business Registers and Statistics, it was asked to the participating ENP-S countries to present the situation reached in their respective statistical system regarding the statistical business register. On the basis of the initial feed-backs, the project elaborated a common questionnaire in order to harmonise the answers from the countries and to present a consolidated regional picture of the « state of the art » in this particular area. This questionnaire was sent to the countries immediately after the Working groups and the returns from the countries were discussed and finalised along the events that were organised by the sector in 2016 and early 2017. The full results are presented in the following section of this report.

MAIN RESULTS

The questionnaire was organised under three types of issues: (i) the general issues, addressing the statistical law and the prescription regarding the SBR, (ii) the content of the SBR and (iii) other questions.

In all the ENP-S countries, the statistical office is the organisation in charge of the statistical business register; this is written in the statistical law for 7 of the countries (exception of EG and JO). Other administration involved are the Ministry of Finances (8 countries), the social security office (7 countries), the customs (7 countries) and other bodies (municipalities in Palestine, Electricity and Gaz company in Tunisia).

The main classification used by the Statistical offices is the ISIC Rev4, but used also by the other actors in only 3 countries (IL, Mo and PS), this making the sharing of information and the cooperation very difficult.

Information that is included in the registers of all the countries are the name, the address and contact, the main activity, the legal form and the date of opening. There are other information available but not in all countries: nationality (7 countries), the employees (8 countries), the profit/loss (6 countries), the turnover (5 countries) and the imports/exports (4 countries). The register is used as the main source for the sampling in the economic surveys of 8 ENP-South countries (exception: JO) and 6 are regularly disseminating demographic data from the registers.

DETAILED QUESTIONNAIRE

The questionnaire that was sent to the countries was built on four components:

- Component 1: Generalities on the Statistical law, on the regulations regarding the sharing of administrative data and information on the organisations and departments involved with the SBR,
- Component 2: Information on the SBR, its creation and updating and on the processes to assess its quality,
- Component 3: information on the content of the SBR, and
- Component 4: other issues.

The answers from the countries are presented in the tables below for each component.

on business demography

In parallel to the gathering of information on the methodologies followed for the SBR, the project also asked the ENP-S countries to share the data on the demography of businesses that they had available. The result is given into the tables and graphs below first on a synthetic format and then for each individual country. Only data for Lebanon are missing at this point. Data are available for two categories: total number of businesses (1 and more employee) and businesses with more than 100 employees. The sources for the national data are the respective NSIs; data are presented for years that are different from country to country, this depending on the date of creation of the register and on the national system used for its updating.

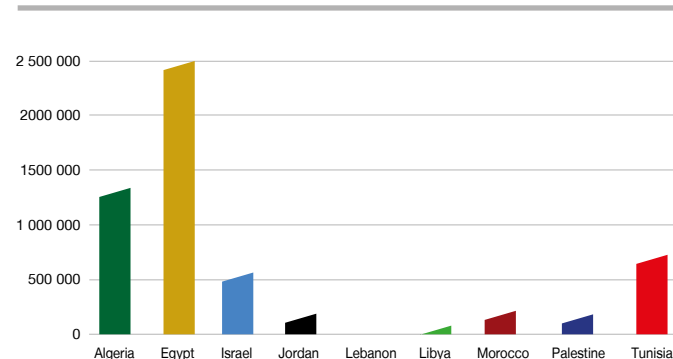
In total, this is Egypt that registers the largest number of businesses (2.410.360) followed by Algeria (1.306.890) and then Tunisia (711.442) and Israel (545.901). In the other countries, the number are above 100.000 (174.155 in Morocco, 159.655 in Jordan, 134.259 in Palestine). In Libya, there are only 16.573 businesses registered.

For Algeria, the register contains only enterprises (and not establishments) for which a Statistical Identification Number (NIS) has been assigned.

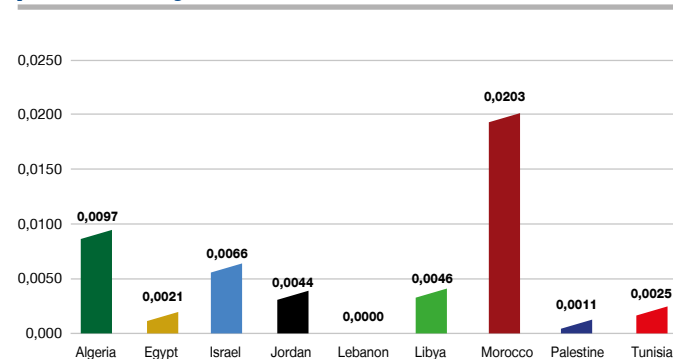
In Morocco, the register contains legal enterprises that hold a complete account and report their income annually to the tax authorities.

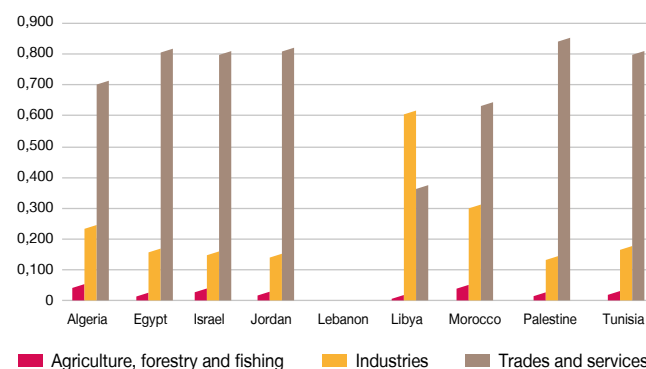
Number of businesses per country

The proportion of businesses with more than a hundred employees is the highest in Morocco (2.03%), Algeria (0.97%) and Israel (0.66%). It stands at less than 0.5% in the other countries.

In all the ENP-South countries at the exception of Libya, the services record the highest number of businesses in proportions that are higher than 70% with a peak in Palestine (86.5%). Industry remains high in Libya (62.4%) and in Algeria (23.6%). Within the services, retail trade is by far the most important activity in all the countries.

DATA PER COUNTRY

ALGERIA

The SBR is updated on a permanent basis and the data in the table below are those of January 31, 2017. They are given by size and by activity. The breakdown by employment bracket is an estimate based on the structure of the 2011 register. The register contains only enterprises (and not establishments) for which a Statistical Identification Number (NIS) has been assigned.
