ENSURING UNIVERSAL AND HIGH-QUALITY ACCESS TO BASIC SKILLS

- Building the capacities of public authorities responsible for primary and secondary education
- Institutional strengthening for the management and evaluation of the education sector
- Initial and in-service teacher training

SUPPORTING THE SOCIO-PROFESSIONAL INTEGRATION OF ALL

- Developing initial and continuing training policies tailored to the needs of the labour market, working with the private sector

PRIMARY EDUCATION SUPPORT PROGRAMME IN THE DEMOCRATIC REPUBLIC OF CONGO (APEP II) 2015-2018 – EUR 2,4M (C2D – AGENCE FRANÇAISE DE DÉVELOPPEMENT)

Beneficiary: Ministry of Primary and Secondary Education and Initiation to New Citizenship

Objective: Ensure free and high-quality access to primary education, in particular via a component to build classrooms, a teacher training component and a budgeting component for teaching positions.

PROJECT TO IMPROVE EDUCATION QUALITY AND ACCESS IN MALI (PAQAMA) 2017-2019 – EUR 1M (AGENCE FRANÇAISE DE DÉVELOPPEMENT)

EUROSOCIAL+, GENDER EQUALITY POLICIES COMPONENT – LATIN AMERICA

2016-2021 – EUR 32M (EUROPEAN UNION) – INCLUDING EUR 8M FOR EXPERTISE FRANCE

Objective: EUROSociAL+ aims to strengthen social cohesion in 18 Latin American countries. The objective of the programme is to combat social inequalities and contribute to establishing closer ties between the two regions. The "gender equality" component aims to strengthen gender equality policies.

2016-2020 – EUR 8,7M (EUROPEAN UNION, FRANCE, BELGIUM, SPAIN)

SOCIEUX+ is an expertise facility that can be mobilised at the request of European Union partner countries to assist them in the implementation of more inclusive social protection systems and the development of more sustainable labour and employment policies. SOCIEUX+ is based on a simple and flexible system to rapidly mobilise mainly public European expertise to meet the specific needs of partner institutions during short-term missions.
