

The Coordinated Maritime Presences (CMP) concept aims to address maritime security challenges in the Gulf of Guinea by coordinating the presences of European naval and air assets. The EU Senior Coordinator for Maritime Security and their team guarantee coherence and coordination of the overall action of the EU and Member States actions and conducts relations with regional partners on maritime security. The CMP framework ensures a continued EU maritime presence and outreach in the region, thus increasing the EU's cooperation and partnerships with the coastal States and the Yaoundé Architecture.
