Cultural and creative industries (CCIs) include the following sectors:

performing arts, visual arts, fashion and design

cultural heritage, museums, crafts, tourism

The cultural and creative sectors help create jobs and promote social cohesion and regional development. AFD Group provides support for structuring cultural and creative ecosystems, with the goals of supporting growth and innovation, promoting our capacity to live together in harmony, and reducing inequalities.

SUPPORT FOR BENIN'S CULTURAL POLICY

€55 M loan and €5 M grant by AFD to the Republic of Benin – technical support from Expertise France

- Help implement cultural sector reforms through public management and decentralization
- Promote the sector's structuring and professionalization: regulatory framework (copyright, legal status of artists, etc.), financing of operators, and monitoring of its contribution to national GDP
- Improve dissemination, access (regional network of cultural sites and venues, artistic and cultural education, etc.), and the promotion of culture

PROMOTE INCLUSIVE REGIONAL DYNAMICS ACROSS MULTIPLE COUNTRIES



REGIONAL PROJECT TO STRUCTURE CCIs IN THE INDIAN OCEAN AREA

€5.1 M grant by AFD to the Indian Ocean Commission

- Boost CCIs by ensuring better governance of the sector, enhancing the cultural heritage of the Indian Ocean region, and supporting initiatives and training of cultural stakeholders
- Reduce gender inequalities, including through actions for the inclusion of women and awareness-raising on gender-based violence

FINANCING FOR CULTURAL SITES TO PROMOTE LOCAL DEVELOPMENT

PRESERVE AND PROMOTE CULTURAL HERITAGE



CULTURAL HERITAGE CONSERVATION FOR FORT LAHORE IN PAKISTAN AND THE URBAN RENEWAL OF ITS SURROUNDING AREA

€22 M AFD loan to the Islamic Republic of Pakistan

- Rehabilitate, conserve, and promote Fort Lahore, and create a visitor center
- Improve urban infrastructure in the buffer zone around the fort
- Contribute to local economic development and initiatives that promote tourism

FINANCE LOCAL CULTURAL INFRASTRUCTURE



REHABILITATION OF THE JACQUES AKA CULTURAL CENTER IN CÔTE D'IVOIRE

€17.2 M grant from AFD (via C2D*) to the Republic of Côte d'Ivoire – technical support from Expertise France

- Improve access to cultural services in Bouaké (library, theater, etc.) by reducing regional inequalities
- Support the structuring and professionalization of the sector through training and business incubation

Support for stakeholders of the cultural ecosystem

AFD Group supports capacity building and access to financing for CCI stakeholders in order to help structure cultural and creative sectors throughout the value chain (for creation, production, dissemination, and distribution).

BUILD THE SKILLS OF PRIVATE AND PUBLIC STRUCTURES



FIT ICC – PROFESSIONAL TRAINING IN THE AUDIOVISUAL AND PERFORMING ARTS SECTORS IN SENEGAL

€2.8 M grant from AFD, via European Union funding, to the Republic of Senegal

- Develop a high-quality and sustainable professional training offer in the audiovisual and performing arts sectors
- Support the sector's development and professionalization, in particular by enhancing public-private collaboration
- Promote the young people's integration into the labor market

FOSTER EXCHANGES AND KNOWLEDGE SHARING



DJOWAMON – PROFESSIONAL PLATFORM DEDICATED TO AFRICAN MUSEUMS AND CULTURAL HERITAGE

Implemented by AFD Group Campus in partnership with the University of Paris 1 Panthéon-Sorbonne and École du Patrimoine Africain, with support from the Zinsou Foundation, the African World Heritage Fund, and Centre Pompidou

PROPOSE A FINANCING CONTINUUM FOR INNOVATIVE ENTREPRENEURSHIP



CREAFUND – GUARANTEE FOR CCI INVESTORS

€6.47 M facility implemented by Proparco via European Union delegated funds, within the framework of the CreatiFI initiative

Creafund encourages financial intermediaries to invest in cultural and creative businesses in sub-Saharan Africa and the Caribbean, via a guarantee mechanism to cover the risk of investment funds. It also supplies technical support.

DIGITAL AFRICA

This Proparco subsidiary boosts and invests in tech startups (including CCIs) from their initial development phases.

SUPPORT CIVIL SOCIETY ORGANIZATIONS WORKING FOR A SOLIDARITY- AND SUSTAINABILITY-DRIVEN ECONOMY



HIKING TRAILS IN THE MIDDLE EAST

€1.8 M grant from AFD (via the CSO Initiatives mechanism) to the French associations AFRAT and TETRAKTYS in Jordan, Lebanon, and Palestine

- Establish a network of long-distance hiking trails in the Mediterranean (Med Trails)
- Develop local economies by supporting community-based initiatives along the trails
- Analyze and anticipate the effects of climate change on hiking tourism and raise awareness among its stakeholders
- Promote natural, cultural, historical, and religious heritage

Mobilizing partners

Faced with the considerable challenges facing the cultural and creative sectors (climate transition and the rise of generative AI in particular), AFD Group mobilizes its financial partners to encourage solidarity- and sustainability-driven investments and to multiply their impacts. It works as part of Team France, drawing from recognized French expertise to accelerate transformations and strengthen links between territories.



THE PUBLIC DEVELOPMENT BANK NETWORK

At the 2023 Finance in Common Summit, the “Coalition for Sustainable Development through Culture and Arts” was launched with several public development banks to foster reflection and joint operations.



EUROPEAN UNION

AFD Group’s three entities can mobilize European Union funds. Expertise France is an EU fund manager for the implementation of Euro-African cooperation programs on performing arts, the audiovisual sector, and museums.



PHILANTHROPIC ORGANIZATIONS AND SPONSORS

Our partnerships with these stakeholders are exemplified by the Metis Arts and Development Fund, which is hosted by AFD. It manages philanthropic funds in order to finance social and artistic initiatives that engage people and support sustainable development.

MUSEUM COOPERATION BETWEEN AFRICA AND EUROPE

€2 M grant from AFD, in addition to contributions from the EU (€15 M), Germany (€2 M), the Netherlands (€500 K) and Belgium (€400 K), making up €19.9 M in all – Implementation by Expertise France (€9.2 M in management) and the Goethe Institute

- Encourage the development of a renewed shared narrative between Africa and France through museum cooperation
- Bolster capacities and exchanges between African and European museum institutions; preserve, document, and better highlight collections; enhance the social function of museums as spaces for dialogue, education, and inclusion



FRENCH PUBLIC AND PRIVATE EXPERTISE



SUPPORT FOR EXPANDING THE MUSIC INDUSTRY IN GHANA

€620 K grant from AFD (via FEXTE*) for the Creative Arts Agency – Implementation by Expertise France

- Strengthen the music ecosystem in Ghana through the structuring of the music publishing sector and the planning of infrastructure dedicated to music distribution, by mobilizing Arty Farty, France’s Centre National de la Musique, and SACEM

DECENTRALIZED COOPERATION BETWEEN ANGOULÊME, FRANCE, AND ZAPOPAN, MEXICO

€1.5 M grant from AFD (via the FICOL*) to the Greater Angoulême conurbation community, in partnership with the Municipality of Zapopan

- Continue the fruitful collaboration between French and Mexican partners to strengthen CCIs in both locations, in particular by supporting the comics and image industries

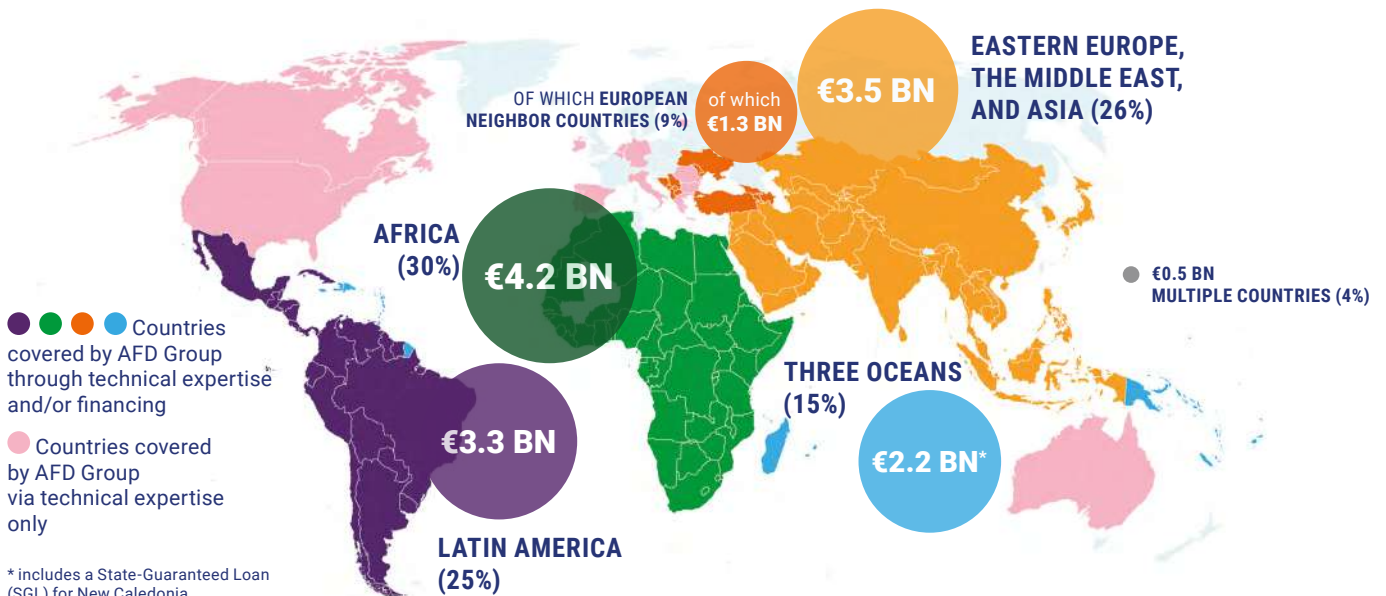
